



## CATALINA THREATENED BY UNIVERSITY HIGH AND TUSD

### President's Message

October 3, 2017, is a date that will stand out in my memory for a long time to come. That is the date of the Tucson Unified School District (TUSD) school board meeting when a small group of teachers and supporters from University High School (UHS) announced that they wanted their own school and they wanted the Catalina campus. If this happens, Catalina students would be sent to Rincon (RHS).

UHS did not speak with anyone at either Catalina or Rincon. They responded to a May 2017 directive from **Mark Stegeman**, a TUSD board member, to tell him what they wanted. It was not a procedure that should have happened, nor was it pleasant to hear them tell us how they planned to rework Catalina to their needs, from repainting the school right down to \$45,000 for patio furniture for the cafeteria court! Currently, Catalina would be happy to have the gas turned on in the chemistry lab!

What followed was a request from the TUSD board to CHS, RHS, and UHS to answer four questions pertaining to such a move. The questions covered possible drawbacks, possible benefits, conditions, and other information needed. The site councils at each school prepared their responses. Our response included nearly everything our teachers, students, parents, and administrators contributed. Our Foundation, while not a member of the Site Council, was asked to present our opinions. The responses were forwarded to the TUSD board and then were formally presented at the November 14 board meeting by our Principal **Antasio Holley** and Vice Principal **Melissa Hall**.

The call to the audience drew many comments, most of which were opposed to the move, including many from former UHS and RHS students, and, of course, CHS alumni, students, and parents. The response was so strong, the school board decided to do what they should have done initially: ask **Mr. Trujillo**, the TUSD superintendent, to make a report on the use of our ten high schools in the district, how they should be structured, where University High might be a good fit,

## GRANTS ASSIST STUDENTS IN MANY WAYS

**Michael Gradowski (\$40)** Originally, Mr. Gradowski requested and was granted \$500 to purchase used professional clothes for his culinary arts students to be able to attend a Culinary Arts Career Day at the Star Pass Marriott. Proper professional attire was a prerequisite for the students to be allowed to enter the day long training and orientation.



Board member **Emily Morrison '60** went into high gear to get CHS alumni and other friends to donate professional clothes that they no longer need since they are retired, and so Mr. Gradowski needed only \$40 to supplement the attire. The students were able to visit the professional kitchens of the Marriott and speak to the chefs in addition to getting advice on expectations for a professional career in the hospitality industry.

**Shane Folsom (\$500)** to purchase team bats for the men's baseball team. The team did not have any team bats and most of the players are too poor to purchase their own bats. The board also provided an additional \$500 to be counted as a spring 2018 mini-grant to be able to purchase the baseball bats needed.

**Obie Tan (\$500)** to support the participation of the men's basketball team in winter tournaments over the holidays. The board also approved a one-time gift of \$500 to help pay for healthy meals and a family environment for student athletes over the holidays. Many of the team members have no or little family and limited funds for food. It is important for them to be well nourished with healthy food to be able to play.

**Elizabeth Cerepak (\$500)** The girls' softball team is starting from scratch. The grant will provide funds for the necessary basic equipment and training that other schools have such as a catcher's mitt, a batting tee, weighted baseballs for hitting and batting practice, a softball hitting net, and admission to the preseason Sabino Tournament to help with training.

**John Gonzales (\$500)** to purchase team uniform t-shirts for the girls' volleyball team. The team was greatly appreciative of having matching uniform shirts. **They also achieved academic excellence by having one of the highest grade-point averages of all the CHS teams.**

**Shane Folsom (\$500)** to underwrite student tickets for various sports events so that students who have little or no funds can attend the various sports events and it can help the teams to have a good audience.

**Melissa Hall (\$450)** in support of the "End of Semester Employee Recognition Luncheon"

**Amy Schull (\$275)** to purchase trash cans to place throughout the campus to help keep the school clean.

**Anastasio Holley/Lori Encinas (\$500)** to support and provide materials for the High School Expo that was held at Catalina for about 2,000 middle school students from all over the city. This event is held at different high schools each year. It helped to showcase Catalina and helped with recruitment and awareness of prospective students and parents that Catalina is a good choice.

**Jenny Miranda (\$498)** to establish a college and career resource library including the purchase of "almost new" books and manuals.

**Janet Lumsden (\$529.94)** for computers and special software used for improving literacy among the CHS exceptional education students.

This provided the students some important real-life learning experiences of paying for their attendance and interacting with other students. It also gave them the opportunity to enjoy attending a prom the way many high school students around the nation are able to do.

**Daniel Lithgow (\$500)** to purchase group t-shirts to promote solidarity for the students in **AVID**, which stands for Advancement Via Individual Determination, which is a national college readiness program designed to help students develop the skills they need to be successful in college. The program places special emphasis on growing writing, critical thinking, teamwork, organization and reading skills.

**Jack Draper (\$500)** to support the participation of the construction skills students in the indoor Habitat for Humanity Cycling event. This provided the entrance fees for the ride as well as a few pizzas during the evening. It also provided a way for students to interact with Habitat for Humanity workers and other construction personnel.

**Monica Holden (\$475)** for lifesaving and lifeguard training equipment which is necessary to be able to learn and practice lifesaving skills and to take and pass the lifeguard certification.

## 2017 TROJAN HALL OF FAME INDUCTEES

**John Bremond '67** has a degree in commercial banking, he formed his own company building custom homes and townhome communities in Tucson, and then pursued real estate investment and business opportunities in Southern Arizona. He was the major supporter of the Catalina LEARN CENTER to assist students to enter the business world.



**John G. Carlton (Faculty)** was the journalism teacher who was the driving influence in the lives of CHS students who went on to careers in journalism, screenwriting, and crossword puzzle making. *The Trojan Trumpeteer* won numerous national prizes and the "Pace Maker" award a record six times. He won several teaching awards.



**George Cunningham '63** was assistant City Manager of South Tucson, first Executive Director of the Pima Association of Governments, and UA Vice-President of Administrative Services. He served eight years in the Arizona Legislature, was Gov. Napalitano's Deputy Chief of Staff for Finance, and co-founded the Grand Canyon Institute "Think Tank."



**Gail Price Grossetta '61** lived and worked on four continents and traveled to more than 100 countries, and led efforts for cross-cultural understanding in the Philippines, Germany, and Italy. She taught International Business at PCC, volunteered with CHS refugee students, earned a pilot's license, and hiked the Grand Canyon from "rim to rim."



**Paul Hazen '59** graduated from the U of A and got his MBA from UC-Berkeley. He joined Union Bank and four years later became the president of Wells Fargo in 1984 and later CEO. He has served on boards of a number of

companies and the San Francisco Symphony and the San Francisco Museum of Modern Art.

**Harold Margolis, MD '64** is a pediatrician. His research and public health work focused on evaluation and introduction of new vaccines, molecular epidemiology of hepatitis viruses, and development of evidence-based public health policy. He retired as director of the Dengue Branch of the Center for Disease Control (CDC) in San Juan, Puerto Rico.



**William Neubauer, MD '61** while in private practice, served on several Tucson hospital boards and chief of surgery. He worked in the barriadas (slums) of Peru and the outback of Bolivia. He has served on many community boards and is the chair of ARSOBO, a disability project in Nogales, Sonora, where wheelchairs and prosthetics are made for the poor.



**Lamond Preston, Ed.D. (Principal)** was the first black teacher to be named a principal in TUSD. He served the fourth principal of Catalina from 1980-1985. He was raised in the barrios of Tucson and served on many local community and educational boards. A memorial fund was named in his honor by the Dunbar Coalition through the Tucson Urban League.



**Margaret H. Wright, Ph.D. '60** is the chair of the Computer Science Department at the Courant Institute of Mathematical Sciences, New York University. She worked for Bell Labs as a Fellow and she holds two honorary doctorates in mathematics. She was elected president of the Society for Industrial and Applied Mathematics.

## ALUM OF YEAR IS CFO OF CHEVRON CORP.

Born in Orange, N.J., **Patricia E. Yarrington** came to Tucson as a young girl. After Patricia graduated from Catalina High School in 1973, she attended Pomona College in Claremont, California, where she earned a bachelor's degree in political science in 1977. From there



she journeyed to Northwestern University in Evanston, Illinois, and received an MBA in business administration from the Kellogg School of Management.

With her business acumen, she joined Chevron Corporation in 1980. "First and foremost, it's important to find work that you love," she says. "I wanted a career. I didn't want to move from company to company."

Patricia went through Chevron's comptroller's department training program and in 1984 she was made senior financial analyst. In 1986 she became manager of Investor Relations. In 1995 she managed Credit Card Enterprises, Marketing, and Chevron Products Co. By 1997 she was comptroller of Chevron Products Co., followed in 1998 by president of Chevron Canada Ltd.

Chevron promoted her in 2000 to vice-president for Strategic Planning for ChevronTexaco. In 2002 she headed corporate policy in Public and Government Affairs. In 2007 she served as treasurer of Chevron.

Then in 2009 she was selected to be vice president and chief financial officer (CFO) of Chevron Corporation responsible for comptroller, tax, treasury, audit, and investor relations activities throughout the Chevron Corporation.

She has been a director of Chevron Phillips Chemical Company LLC since July 31, 2001. She serves on the San Francisco Federal Reserve's Economic Advisory Council and provides information to the Fed on the state of the economy, as well as current and pending development in the energy industry.

Beginning 2009, Patricia became deputy chairman of the Federal Reserve Bank of San Francisco. She served as the chairman of the San Francisco Federal Reserve's board of directors in 2013 and 2014.

Unfortunately, Patricia was unable to attend the induction of the 2017 Trojan Hall of Fame due to business commitments, but she sent a lovely letter expressing her pleasure at being recognized by her alma mater.

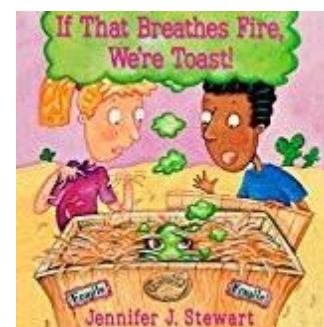
## ALUM HAS CLOSE ENCOUNTERS IN NEPAL AT THE CHS FOUNDATION MARCH SOCIAL
